


Accessing the Online Tax Payment System

Searching for a Parcel

When using the search panel, **enter only minimal information** to improve search results.

Recommended search methods:

- **Parcel Number:** Enter the parcel number only.
- **Address Search:** Enter the **house number and street name only**.
- **Fire Number:** Enter the fire number in the **House # field**.
- **Multiple Parcels / Names:**
Use a **percent sign (%) before and after a common word** found in all deeds.

Example:

%Smith%

Limiting Search Results by Tax Year

You can restrict results to the **current tax year** by:

1. Entering the same year in both the **Starting Year** and **Ending Year** fields under **Tax Information**.



Selecting the Payment Amount

1. Click the **Select** button to indicate how much you wish to pay.
2. Click **Apply** to confirm the payment selection.
3. Click **Checkout** to proceed to payment entry.



Payment Processing

Payments are processed through a third-party vendor: Value Payment Systems (VPS)

Payment Fees

Payment Method	Fee
Credit/Debit Cards (American Express, Discover, MasterCard, Visa)	2.39% convenience fee (\$2.00 minimum)
PayPal	2.39% convenience fee (\$2.00 minimum)
Personal Visa Debit Card	\$3.95 fee
eCheck	\$1.50 fee

Important Payment Notes

- **Do not select a Savings Account when using eCheck.**
The eCheck feature is for **checking accounts only**.
- Payment confirmation **does not guarantee** that the tax payment has been successfully completed.
Transactions may decline for several reasons.
- Users should **monitor their parcel record online** to confirm the payment has been applied **before the tax due date**.

Verifying Payment Status

To verify that your payment has been applied:

1. Return to the parcel search page:
https://www.co.pierce.wi.us/departments/land_management/forms_and_information/tax_and_land_information/index.php
2. Search for your parcel again.
3. Instead of selecting the checkbox, **click anywhere within the parcel row** to open the parcel details.
4. Select the **Taxes** tab at the top of the page.
5. When the payment has been processed, it will appear in the **Payment** section.
